Sixteen girls were interviewed for Tech Trek Scholarships. They were from CTEnglish, Fisher Middle School, Redwood Middle School and Saint Mary's. They all had been recommended by their science or math teachers. They all answered questions the committee asked and had written a composition about why they would like to go to Tech Trek Science/Math Camp.



The hard part for the committee was to pick just four girls. At the time we had enough money for just four girls. One of the committee people asked about the amount needed to send another girl and was told \$600. With that she gave us a check for \$600; therefore, we are now sending five girls to Tech Trek this July at Stanford University. Wonderful!

Focus on the Bridge Groups

Our branch has eleven different Bridge groups. To me, the amazing thing is that these bridge groups have been active for years. Many of these women, who have become friends for the long term, have played and continue to play bridge in one or more of these groups. In fact, one told me that AAUW performs a wonderful service in introducing us to so many *interesting women* who only become *interesting friends* over time. Playing bridge brings them together once or twice a month for many, many years of friendship.

Four of the eleven groups play Duplicate Bridge, which means they are serious about competitive bridge. I visited Louise Quenon's home where they were playing Bridge with Chicago-style scoring and have been together since 1975. Louise Quenon and Teri Raynaud have been in that group since the beginning and Gerry Furman joined a few years later. The other five have replaced previous members. They have so much fun. I wished I was a bridge player!

At Ann Griffin's home I met a group playing Duplicate Bridge in which the two tables play the same hand and compare how the players differ in the way they play it. The two tables are often placed in separate rooms. This particular group originated in 1988 by Betty Thompson who is still a part of it. Not all of the same people are still members, but some are.

I visited a regular Bridge group at Peggy Johnson's home. They have been together since the 1970s also, but they had many more members at one time. They still enjoy playing with each other enough to play twice a month.

The Bridge groups collect \$1 or \$2 per player depending on the group. This money adds up over the year and is donated to benefit the EF or the branch.

Recognition of International Women's Day

The President and Mrs. Obama celebrated International Women's Day with a reception at the White House. While the President acknowledged women who have broken through barriers to pave the road for others, he also made clear that today's reality is still marked by unfairness and inequity for women.

The U.S., with a ranking of 31st on the World Economic Forum, lags behind many other countries in measurements of gender equity. Citing research that suggests public policy plays a significant role in gender equity, the President's remarks stressed his desire to continue to help America achieve fairness and equality for all women.

AAUW strongly believes in its mission to advance equity for women and girls through advocacy, education, and research. Take Action! Urge your senators to support the Paycheck Fairness Act.

Women's Super Agency with the UN

AAUW Director of Fellowships & Grants Gloria Blackwell represented AAUW at the 54^{th} United Nations' Commission on the Status of Women. The session, running March 1-12, is developing momentum and conversation about the UN's goal to combine all departments on women into one Super Agency.

The agency has frameworks pre-approved by the General Assembly, but is still in the process of naming a launch date and an undersecretary. The budget will run from a half billion to a billion dollars and looks to work on issues like education, health, poverty, violence, media, decision-making, and the girl child.

Activists around the globe are currently pushing for a 5th World Conference on Women to further develop the project.

Recollections of the 1980's

The decade of the eighties saw members visible in the community in various ways; for six years the Saratoga Citizens of the Year were members of our Branch of AAUW.

Our Committee on *Homeless Women* and *Children* was probably the most active and visible group. Georgia Travis initiated the work in 1985 as a Woman's Issue and by 1986 it was presented to Inter-Branch and became a county Committee. In the Spring of 1987 Georgia received the Santa Clara County Human Relations/Human Rights Award. She became a member of the Senior Hall of Fame for her work in research and program development in addressing the problem of Homeless Women and Children.

1981-1982

Marge Bunyard was Saratoga Citizen of the Year.

Marlene Duffin was elected to the Los Gatos /Saratoga Joint Union High School Board.

1982-83

Nancy Hobbs, President, started with the *New Day Beyond Era* celebration on the Los Gatos City Hall lawn July 1. The Branch supported the Older Women's League Conference and participated in the Soroptimists' *Come Blow Your Horn* luncheon.

1983-1984

We turned around a membership decline, thanks to the work of many members. Our official number as of March 1 was 436. There were new Inter-Branch involvements such as the Condoleezza Rice Kickoff for the *Peace and National Security* and an exhibition for business women at the IBC Reception for the University of Santa Clara Graduates.

Peggy Corr was Saratoga Citizen of the year. Five of our members served on school boards: Dr. Evers, Marge Bunyard, Marlene Duffin, Liz Ansnes and Mary Ellen Comport.

1984-1985

Kay Eschleman read her President's job description: "Conduct general meetings, write a message for the Grapevine, and dress appropriately." At the installation, the executive board wore hats and gloves! Some had trouble finding gloves.

1985-1986

Jan Leyse's year Women's Work; Women's Worth was introduced and Public Support for Public Education continued. The branch established a scholarship endowment at West Valley Community College in memory of Sammye Wishneff to benefit re-entry women.

1987-1988

Gladys Armstrong was Saratoga Citizen of the Year. The *Homeless* Committee presented a position paper which was adopted at the CSD Convention.

1988-1889

JoAn Lambert and Betty Pestka received awards from the Santa Clara Commission on Human Relations.

1989-1990

Nancy Anderson was our President. At this time the Branch became active in the "women's right to choose movement."

One effect of the Loma Prieta Quake was Senator Rebecca Morgan's cancellation of her appearance as speaker at the Branch meeting; she was in Washington D. C. to get emergency funding for this area. Another was the loss of one of the houses on our House Tour. The home replacement was Steve Wozniak's home (of Apple Computer fame) in Los Gatos.

Louise Cooper was the Saratoga Citizen of the Year.

The Paycheck Fairness Act

The Next Step in the Fight for Pay Equity

April 28 is Pay Equity day this year, designated as the day that women catch up to men in earnings, since women earn 77 cents for each dollar men earn per hour.

A much needed update of the 45-year-old Equal Pay Act, the Paycheck Fairness Act is a comprehensive bill that would create stronger incentives for employers to follow the law, empower women to negotiate for equal pay, and strengthen federal outreach, education and enforcement efforts. Championed by longtime AAUW friend Rep. Rosa DeLauro (D-CT), the bill would also deter wage discrimination by strengthening penalties for equal pay violations and by prohibiting retaliation against workers who ask about employers' wage practices or disclose their own wages. Together with the Ledbetter bill, this critical piece of legislationcan help create a climate where pay discrimination is not tolerated, and give the new administration the enforcement tools it needs to make real progress on pay equity.

With a record 71 million women in the workforce, wage discrimination hurts the majority of American families, both in terms of their economic security today and their retirement security tomorrow.

New legislation strengthening pay equity laws is needed now more than ever, since women tend to be hurt first and worst during economic downturns and would benefit from an immediate "equity" economic stimulus. Further, due to rising unemployment rates, an unprecedented number of women are now the family breadwinners – making pay equity even more critical not simply to family economic security but also to the nation's economic recovery.

Contact your Senators and urge them to vote for The Paycheck Fairness Act.

SBA Proposes Opportunities for Women-Owned Businesses

The U.S. Small Business Administration (SBA) has proposed a **rule** that will expand the availability of federal contracts for women-owned small businesses.

Although women-owned businesses are playing an increasingly important role in the economy, there are still 83 industries in which they are not adequately represented. The SBA rule would ensure that businesses owned and operated by women, specifically those within such industries will have greater access to compete in the federal marketplace and for federal contracts.

AAUW applauds the SBA proposal, which will help to provide an equal opportunity for business owned and operated by women. These efforts will help to remove economic barriers so that all women have a fair chance.





Lavonne's Portuguese Beans

Makes: 10 generous servings

1/2 lb. ground chuck (optional)

1 lb. linguisa, thinly sliced

- 3 cloves garlic, minced
- 1 large onion, chopped
- 1 (15 oz.) can tomato sauce
- 3 tblsp. honey
- 1 tblsp. brown sugar (optional)
- 2 to 3 tblsp. catsup
- 3 tsp. cumin
- 6 cans pinto beans (reserve the liquid from two cans)

Salt, taste and add as needed White Pepper, to taste

- 1. In a large Dutch Oven, brown ground chuck (if used) and linguisa. Add and saute onions and cook until they have softened. Add and saute the minced garlic during the last minute.
- 2. Add the tomato sauce, honey, brown sugar (if used), catsup and cumin. Stir to mix.
- 3. Then add the drained pinto beans and enough reserved liquid to thin the mixture so that it isn't too thick. Save any remaining bean liquid. Mix well.
- 4. Bring bean mixture to a full simmer (*Do NOT Boil*). Reduce heat and simmer for at least 2 hours. (Add any of the reserved liquid during the cooking time to thin the mixture as needed.) Add salt and white pepper to taste near the end of the cooking time.
