The winter issue of Outlook, the AAUW magazine, highlights the latest AAUW research report, Graduating to a Pay Gap, which finds that the gender wage gap is alive and well, starting with the very first paycheck that women receive after graduating from college. Just one year out of college, women are paid 82 cents, on average, for every dollar paid to men. AAUW will continue to lead the way to break through the barriers that stand in the way for women and girls. The portion of your dues that goes to AAUW helps support this kind of research and national advocacy efforts.

Homeless Committee Report: Reopened Casa de Clara – San Jose Hospitality House

Mary Ann O'Conner, of Casa de Clara — Catholic Worker, (a Hospitality House located in San Jose) was our speaker for March 2013 Homeless Committee meeting. She explained that the Catholic Worker's movement was started by Dorothy Day (1897 -1980). Day was an American journalist and a social activist who converted to the Catholic faith in 1927. In 1933. Day co-founded The Catholic Worker, (a newspaper) which promoted Catholic teachings and tackled societal issues. The newspaper became very successful and spawned the 'Catholic Worker Movement', which tackled issues of social justice guided by its religious principles. Day also helped establish special homes to help those in need.

MaryAnn had been a nursing supervisor at Stanford when she retired, sold her house in San Diego, and moved to San Jose to reopen Casa de Clara, which had been closed for 6 months. Since Mary Ann has only been in the area 6 months, she asked Pat Khan to explain the work of the branches' Homeless Committee for Women and Children. Mary Ann was surprised to hear all about the work we have accomplished over a great many

years. Pat Kahn explained that the committee, at one time, had been much larger.

Casa de Clara is located in an old Victorian house in downtown San Jose, near 6th and Julian Streets. It is independent of the Catholic Church and receives no government funding. Casa De Clara depends on donations, and the help of volunteers. [For more information about Casa de Clara, read their blog at .blogspot.com/" http://sanjosecatholicworker.blog spot.com/]

Casa De Clara offers shelter, 'a bed', in a family like atmosphere for women and women with children. Clients must be able to work with each other, treat each other with respect and eat dinner together. The clients have chores to do in the house. All the clients are working on their own goals and receive help with their problems. When the clients move in, they must surrender their money, and it goes into a checking account. When they move out, their money is returned. Unlike other shelters, there is no time limit to how long they may stay. At this point there are 9 single women, and 1 woman with a 10 yearold child and 3 month-old baby. The

mother, with the baby in a stroller, takes the girl to school every morning by bus and light rail to her 4th grade class in Campbell. This is about 1 1/2 hours trip each way.

Like the majority of shelters, the clients are expected to be gone during the daytime hours. The live-in staff consists of only Mary Ann and a young man in his early 20's. Mary Ann has her own income to support herself and the young man supports himself with two part-time jobs. The shelter also gratefully relies on volunteers, who by living simply and donating their life to serving others, make Case de Clara work. The shelter staff and volunteers (along with the clients) keep the shelter running by doing the cleaning, the laundry, the cooking, and the gardening.
