

More thanks are in order to the students serving at the tea who came from **Saratoga High School Interact Club** and **Lynbrook High School Octagon Club**. The beautiful centerpieces were provided by **Jean Knofler**. And many thanks to everyone who contributed silent auction items and jewelry for the event.

Proceeds from the Tea will benefit our three local projects: Tech Trek science/math camp at Stanford University; Local Scholarships for women transferring from West Valley College to a four-year college; and the Committee on Homeless Women and Children which supports agencies working with homeless women and their families.

AAUW was well represented at **Lilly Ledbetter's** keynote speech at the South Bay Women's Conference on March 8 at San Jose State University. Lilly talked about her years working as a supervisor at the Goodyear Tire plant and detailed the high points – and low points – of her subsequent long legal battle to get equal pay for equal work. She pointed out that her unequal pay led directly to lower retirement benefits, reduced overtime pay and lower Social Security income which continue to affect her and her family financially. Her book, *Grace and Grit: My Fight for Equal Pay and Fairness at Goodyear and Beyond*, is available online and in book stores.


# Report from the Nominating Committee

E3 = Engage, Educate, Empower - April 11-13, 2014


Regular registration (\$249) has been extended through March 31. Late registration (\$279) begins April 1.

#### Help Keep AAUW CA Strong, Growing and Vibrant.

Voting for AAUW CA runs from April 12 – May 2. This year, let's all vote and keep AAUW CA strong and vibrant, serving the Branches! You will receive an email alert with the online voting instructions or, if you don't have email, a postcard with instructions on how to request a ballot.

This is an important year for voting as the AAUW CA Board of Directors has put on the ballot a \$4 state dues increase. This would increase the state dues from \$16 to \$20 starting July 1, 2015.

**Does this sound familiar?** Yes, it does, because we voted on this last year but the dues increase needed a 2/3 majority to pass and the vote fell short by less than 3%. It has been ten years since the last dues increase and during that decade the cost of doing business has grown significantly.

Being on the AAUW CA Board of Directors for almost two years, I have been very impressed with how hard the Board members work and how careful all Board members are with the dues income available. Many cost-cutting measures have been undertaken: moving the state office into a space shared with other non-profits which is a much less expensive space; state conventions are now every other

year; the state board has been reduced in size from 36 (a few years ago) to 12; and emailing of the CA Perspective. One can still opt to receive a hard copy, but electronic mailing is significantly less costly.

For the past several years, the state organization has had to dip into reserves to the tune of \$30,000-40,000. This is unsustainable. Action needs to be taken now to insure that, starting in 2015, AAUW CA will receive sufficient income to operate.

The Dues Analysis Task Force Report with Recommendations offers further details and clarification. This document can be found at www.aauw-ca.org under the AAUW CA Business tab as the first item listed under Finance.

CA AAUW provides crucial support to the branches, including fiscal and legal oversight and structure; statewide programs including Tech Trek, Speech Trek, Financial Literacy (Start \$mart), and Leader on Loan; leadership training; mission based program, membership and AAUW Funds support; and public policy emphasis, including the Sacramento legislative lobbyist.
