### **About the Books Written by this Year's Authors** Join Us at the Author's Luncheon on January 25.

The Home for the Friendless: Finding Hope, Love, and Family, by Betty Auchard. Auchard has perspective and joy when she talks about her childhood. "We had so much fun with no money," Auchard said. "We made up games, and we would make forts out of bushes or boxes or a few boards we found. We didn't realize it at the time, but we were having a blast, and it was all free."

Auchard grew up in Iowa as the oldest of three siblings, with parents who weren't always the model of familial stability. Breaking up and reuniting multiple times over the years, Auchard's parents often placed them with extended family members, and, for a time, the children were left at the Home for the Friendless, an orphanage in Cedar Rapids.

"My parents worked really hard at it," Auchard said, "but they just couldn't keep it together. In retrospect, my mother was very gifted, but probably bipolar. There were times I was really bummed out because it was hard to live the way we lived."

Auchard's memoir is a large collection of short stories, each with a memory. They are sometimes poignant and painful, such as the day Bobby's birthday cake was destroyed by their temperamental mother. Others are humorous, like the day Betty learned the F-word from a bunch of other orphanage kids. *Excerpt from a book review by Laura Millsaps*. *For the Love of Aimee: A Memoir* by Julie Matsushima. The story of a grandmother's devotion, and the courage and faith it took to help her granddaughter—diagnosed with irreparable brain damage from birth—beat the odds.

Aimee and her twin sister were the first grandchildren born to Julie Matsushima, but the family's joy at the birth quickly turned to panic when Aimee was diagnosed with irreparable brain damage.

For the Love of Aimee invites you to share in the disappointments, challenges, and amazing achievements Aimee and Julie experience as this grandmother and granddaughter embark on a journey to find a breakthrough for Aimee. As they travel around the world, seeking treatment and meeting many other families with children with disabilities, Aimee's enthusiasm, confidence, sense of humor, and positivity profoundly affected all who witness—in disbelief—her astounding accomplishments.


This incredible book will move and inspire you, particularly if your life has been touched by a child with special needs. Aimee's extraordinary story shows that, without a doubt, supportive and involved parents and grandparents make every difference in the lives of children with disabilities. *Excerpt from a book review*. *The Chinese Dream* by Helen Wang. The yin and yang gulf between the fierce individualism of the typical American and the "*collective interest*" of the average Chinese is so wide that the best we can hope for is a harmonious understanding of just how very different we are. This is a profound book—profoundly uplifting and profoundly troubling.


The Chinese Dream is written on three levels. First is a recitation of the economic and urban population growth of the new China, and it is staggering.


The second level is Wang's many interviews with Chinese entrepreneurs, emerging market leaders. There is Jack Ma, the owner of Google's Chinese competitor, Alibaba (whose IPO on the Hong Kong exchange rang up \$1.5 billion).

The third level is Helen Wang herself, with personal stories of her voluntary nomadic life half in America and half in the Middle Kingdom, and her attempts to bring them into harmonic convergence, with varying degrees of success.

The whole point of Wang's book—that a burgeoning middle class in China is inevitable is also classic yin and yang. No one can deny that the American dream of a car, a home, and a good education for the children should not be withheld from middle class Chinese. *Excerpt from a reviewed by Jack Shakely.*

## **Local Homeless Situation in Santa Clara County**

Happy New Year Everyone,

Lets see - it is now 2012 - that number happens to be 108 less than the number of homeless children in San Francisco.

# As we start the year here are some interesting facts picked from the *Santa Clara County 2011 Employment Services Report*.

Currently, 37,602 individuals (*singles, families*) receive CalWORKS assistance. As a condition for receiving cash aid, all adults must participate in welfare-to-work activities through Employment Services. CalWORKS regulations require single-parent families to engage in 32 hours of activities each week and two-parent families to participate in 35 hours. (*There are some exemptions depending on family situation*).

We found two parts of the report unusually interesting. *The Teen Parent Program* (*teen childbearing costs taxpayers nationally over \$9 billion each year – yes, that was with a* "*B*"). Santa Clara County served over 500 participants in this program achieving a 79% graduation rate. However, case managers have noticed that a distressing number of clients under the age of 16 years is growing. The other section of interest was *the Refugee Program*. For the last federal fiscal year California received 15% of the new arrivals. The pie chart shows the breakdown of countries as:

Iran - 45.9% Iraq - 24.5% Burma - 9.4% Eritrea - 8.2% Asia - 7.5% Africa - 4.4%

Contrary to the *San Jose Mercury News* article on 12/07/2011, that stated that the South Bay job market grew by 3.2%. The County report show the 2010-2011 unemployment rate persists at 10%, which is above the national average, while unskilled and limited language unemployment remains higher still. These few jobs that are available tend to require professional training, new accreditation, experience, and communication skills - qualifications that many refugees (*and teen parents*) lack or have difficulty obtaining quickly.

## Help Keep Access to Birth Control Available to All Women

It's a fact that nearly every sexually active American woman will use some form of birth control in her life. Whether they use it to prevent pregnancy or whether they're among the 1.5 million women who are prescribed birth control for other medical needs, contraceptives are a real and critical part of women's reproductive health.

Incredibly, some powerful opponents of women's health want to make it harder for you and other American women to access birth control and other contraceptives.

Here are the basics: A few months ago, AAUW cheered the Department of Health and Human Services' recommendation that new insurance plans cover women's preventive health care without copay. But right away, opponents started undermining this decision with exemptions for certain religiously affiliated employers. This exemption is an obvious intrusion on the patient-doctor relationship, and also discriminates against women on the basis of sex.

So we need YOU to raise your voices for the millions of women who work for religiously affiliated schools, hospitals, charities and nonprofits — AND their dependents — and ask the Obama administration to oppose these attempts.

Call right now and tell the White House: Oppose attempts to exempt employers from covering women's preventive care — all women should have coverage of contraception without copays or cost-sharing.

## Sexual Assault Victims in Military

Senate Approves a Bill Offering Greater Protections for Sexual Assault Victims in Military

The Senate approved a bill that will grant victims of sexual assault in the military greater legal protections. Authored by John Kerry (D-MA), the Senate bill mirrors legislation that was passed in the House earlier this year. It provides victims of sexual assault in the military the right to legal counsel, confidentiality, and the opportunity to transfer to another base. Only 8 percent of military sexual assault cases end in prosecution, yet one in three women service members reported experiencing "some form of sexual trauma" during their service.

AAUW strongly believes that all people deserve a safe, welcoming, and harassment-free work environment.

## Branch Voted to Support S.B. 810 – California Universal Health Care Act

At its October 4 meeting, the Los Gatos-Saratoga Board voted unanimously to support Mark Leno's S.B. 810, the California Universal Health Care Act, which would be similar to Medicare for everybody. Over 170 other organizations have endorsed the bill, including AAUW of California, Goleta Valley, Pasadena, and Santa Maria.

#### Summary of S.B. 810

A bill to establish universal healthcare through publicly financed administration was authored by former State Senator Sheila Kuehl as Senate Bill S.B. 840. This was the first single payer bill that a state legislature ever sent to a governor in our nation's history. In fact, S.B. 840 was passed by the California Senate and Assembly twice, in 2006 and in 2008. However, Governor Arnold Schwarzenegger vetoed the bill both times.

Senator Kuehl was termed out in 2008. In 2009, Senator Mark Leno introduced the same bill, which was re-numbered as S.B. 810, and it was recently reintroduced as S.B. 810 in February 2011.

A copy of S.B. 810 is available for download on Mark Leno's website. Also available is a very informative comprehensive Fact Sheet.

#### Advantages of SB 810

*Security* - Everyone is covered. No one will ever lose coverage for any reason. Coverage is based on residency, not employment.

*Choice* - Everyone can choose their doctors and other providers. Under this single payer plan, health care delivery is in the private sector and is not a socialist system.

*Comprehensive Benefits* - Everyone has full benefits that include prescription drug coverage and mental health care. *High Quality* - Doctors and patients, not administrators, make medical decisions. Hospitals can afford safe staffing levels for registered nurses. Primary and preventive care are priorities. *Efficient Administration* - Huge savings result from removing insurance companies from health care. Provider and

patient paper work is slashed.

*Fair Cost Sharing* - Employers and employees pay a modest health care premium, which is less than most pay now. *Fair Reimbursement* - Providers receive fair and full compensation for their services.

*Cost Controls* - Health care inflation is controlled by efficient administration, global health care budgets, bulk purchases of drugs and durable medical equipment, coordination of capital expenditures, and linkage to growth of the State Gross Domestic Product.

## **Great Decisions 2012 Begins February 2**

Great Decisions 2012 Coordinator Rosalie Price reports that a total of 62 persons have signed up to participate in this year's local Great Decisions program. Forty-two of those have elected to participate in Group One which will meet in the Saratoga Area Senior Coordinating Council's modular classrooms. (This is the same location that Group One has met in past years.) Also, as in the past, the twenty participants who have elected to participate with Group Two will hold their meetings at the Saratoga Retirement Center. Members of Group One only will receive their course materials at an organizing meeting in the SASCC modular classrooms at 1:00 pm on Thursday, January 26, 2012. At that January 26th "Group-One-Only" meeting volunteers will be identified to serve as individual topic leaders.

The two separate groups will then meet for the remainder of the 2012 season's program as follows: (**Group One**) eight bi-weekly sessions held on the first and third Thursdays of each month from 1:00 to 3:00 pm in SASCC's Modular Classrooms; and, (**Group Two**) weekly sessions for eight consecutive weeks from 2:00 to 4:00 pm at the SRC. The first regular session for each group will begin on February 2, 2012.

-Program leaders are Al and Anne Stewart who will also lead **Group One**. Program coordinator is Rosalie Price who will be lead **Group Two**. John Price does the program's financial accounting.


## More Cuts Planned for Osteoporosis Testing

Medicare reimbursement rates for osteoporosis testing will continue to decline without congressional action. A National Osteoporosis Foundation study released this week found that reimbursement dropped 56 percent from 2007 to 2010 for tests done in physicians' offices. In addition, testing has stagnated in recent years after a decade of growth. A bipartisan bill, Preservation of Access to Osteoporosis Testing for Medicare Beneficiaries Act (S. 1096/H.R. 2020), would extend the minimum payment for osteoporosis tests through 2013.
