Age Discrimination Case Could Have Far-Reaching Effects

Recently, the Supreme Court heard the first in a series of age discrimination cases on their docket this session, and their decision in the case could limit the scope of federal laws designed to protect women and others from workplace discrimination. According to *Women's eNews*, the case, brought by a woman who lost her job at age 51, aims to ease the burden of proof for victims of age discrimination. While nearly two-thirds of age-discrimination cases are brought by men, the number of cases brought by women is on the rise, and the effects of age discrimination may be harder on women. Women also reportedly begin to report age discrimination at age 40, a full 10 years earlier than men. Because of the continued pay inequity between men and women, and fewer years in the workforce due to family responsibilities, women often have less savings and lower pension benefits. With the increased life span for women, many are forced to stay in the workplace longer as well. The Court is expected to rule on the case before it adjourns in June 2008.

Women age 65 and over have substantially higher poverty rates than men. In fact, more than half of older women would fall into poverty without Social Security benefits. As many women depend on Social Security as their primary source of retirement income, AAUW believes that any Social Security improvements must maintain guaranteed benefits and consider the inequity of pension benefits and retirement security for women. AAUW is firmly against privatizing all or part of the current Social Security program, since that would eliminate many of the guaranteed benefits women need and jeopardize important benefits to children, especially women and children of color. Social Security's long-term solvency needs to be strengthened, not weakened through privatization

Great Decisions

Great Decisions 2008, which is sponsored locally by the League of Women Voters, the American Association of University Women, the Saratoga Area Senior Coordinating Council (SASCC), and the Saratoga Retirement Community (SRC) will officially begin its new season on February 7. However, only for those Great Decisions members who will be participating in Group 1, an organizational meeting will be held at the Saratoga Area Senior Coordinating Council (SASCC) portable classroom beginning at 1:00 p.m. on January 31. Workbooks will be distributed at this meeting and volunteers will be solicited to chair each topic's discussion at the eight regular sessions.

Regular sessions for **Group 1**, as well as for **Groups 2 and 3**, will begin on February 7. All three groups will meet in the same locations as in past years. The topic for each of the first sessions will be "Iraq Endgame." The seven subsequent topics will be "European Union at 50," "Talking to Our Enemies," "Russia, U.S. Defense and Security Policy," "Latin America," "U.S-China Trade Policy," and "Private Philanthropy."

Group 1 will meet in eight bi-weekly sessions held on the first and third Thursdays of each month from 1:00 to 3:00 p.m. in the portable classroom at the **SASCC**, which is also sometimes called the Saratoga Retirement Center near the Saratoga City Hall; **Group 2** will meet in eight consecutive weekly sessions from 9:30 to 11:30 a.m. at the **SRC**; and, **Group 3** will meet in eight consecutive weekly sessions from 2:00 p.m. to 4:00 p.m. at the **SRC**. Programs such as the Male Involvement Program, Community Challenge Grant Program, Information and Education, TeenSMART Outreach and comprehensive sex education in our public schools help to bring comprehensive medically-accurate health information to our youth, enabling them to make responsible choices about sex. Learn about PPMM's programs.

Looking to the future: With new studies showing the effectiveness of providing youth with comprehensive information covering abstinence, contraception, sexually transmitted infections, and decision-making and skill-building activities, we know how to continue to make strides forward in reducing teen pregnancy. We are focused on maintaining California's successful programs and continuing to improve the quality of comprehensive sexuality education in our schools and communities.
