Homeless Committee

Christine Burroughs, Executive Director of InnVision, and Julia Burkhead, Director of the Georgia Travis Center, were the guest speakers at our November meeting. InnVision is the umbrella agency serving the homeless and at-risk families in Santa Clara County. Under their administration are of some of the following facilities in and around San Jose: Montgomery Street Inn for men, Julian Street Inn, Stevens House, and Alexander House for those with mental disability. Commercial Street Inn and the Villa provide housing for women and children while the HomeSafe program provides shared housing for victims of domestic violence. Additional programs provide food, clothing and help with crisis problems as well as providing guidance, tools, and resources to clients seeking self-sufficiency. In addition to these programs, InnVision has multiple agencies along the Peninsula as far north as San Mateo. This past year InnVision has provided service to over 20,000 individuals, up 4,000 from last year.

Of course, as our Georgia Travis Center (GTC) is part of all this, it was interesting to hear from the speakers about the changes soon to happen. As with every non-profit agency, donations are down just as need is up. This will mean cuts in some programs but new programs will help counteract them. Two of the new ventures are a full-time day care facility and "One Stop," collaboration with the City and County to bring a multiple of services to low-income families and individuals. Director Burrough's closing statement said it all, "I think GTC will be what

Public Policy

California Congressman Henry Waxman has submitted a letter to Secretary Michael Leavitt, head of the Department of Health and Human Services, challenging the process used by HHS to review and rewrite the proposed healthcare provider conscience/right of refusal regulation that seeks to protect "the right" of health care individuals and entities to refuse to perform medical procedures, including abortion and sterilization, and to refuse to sell birth control. Mr. Waxman is the Chairman of the House Committee on Oversight and Government Reform.

The letter reads in part, "...it has come to my attention that the rule was issued in apparent violation of an executive order that requires interagency coordination and review. I am writing to request an explanation of this lapse and a description of how HHS will redress this lack of coordination in conjunction with the Office of Management and Budget and other affected federal agencies." The letter went on to detail Mr. Waxman's concerns.

Mr. Waxman's letter should significantly delay HHS's regulatory process. HHS has already missed the 30-day deadline to publish responses to comments received during the public comment period. AAUW CA and its allies are hopeful this additional delay will result in the proposed changes being abandoned altogether. That is unlikely but the missed deadline opens other avenues of opposition to the proposed changes. Gladys Bernyk



A New Birth of Freedom'—2009 Inaugural Theme

"A New Birth of Freedom" commemorates the 200th anniversary of Abraham Lincoln's birth. The words, echoing across 200 years from Abraham Lincoln's Gettysburg address, express Lincoln's hope that the sacrifice of those who died to preserve the United States would lead to "a new birth of freedom" for the nation.

2009 Theme Selection

The theme was chosen by the Joint Congressional Committee on Inaugural Ceremonies in consultation with the Senate Historian's Office. Inaugural themes are incorporated into the official Inaugural program, Inaugural Luncheon menu and decor.

Swearing-In Ceremony

The Swearing-in ceremony takes place on the West Front of the U.S. Capitol with the president-elect being sworn-in by 12 noon on January 20. Amendment XX to the U.S. Constitution states that the term of the President expires at noon on January 20.

Author Biographries

Arlene Blum

is well-known as an author, feminist, and activist. Her fame is not for any of these things, but for being the first woman to lead an all-woman team to climb to the top of Annapurna. This is one of the highest peaks (26,546 feet) of the Himalayan mountains in central Nepal. She will be known forever for her slogan: "A woman's place is on top." She has used her mountaineering experience as a metaphor in addressing women, challenging them to conquer life's challenges. She also is a writer, publishing "Annapurna: A woman's place," "Breaking Trail: A climbing life," as well as monthly email newsletters, in which she urges action on many issues of interest to women.

Amanda Scott

is a native-born Californian. She has during her lifetime been in a gifted child program, worked as a model, and taught in the Salinas School District. Her undergraduate work was done at Mills College in Oakland with a major in History. She later attended University of North Carolina and San Jose State University, receiving a Master's in British History. She started writing novels on an old Smith-Corona portable electric typewriter, and has since graduated to computer data processing, More than 25 (yes, 25) of her historical fiction novels are set in the English Regency period (1810 to 1820), while others are set 14th- through 18th-century Scotland. She and her husband and children now live in Napa.



Penny Warner

is from Danville, CA, has published over 50 books, both fiction and non-fiction. She received a Bachelor's degree in Child Development and a Master's degree in Special Education. She teaches seminars on writing tips. Altogether, her books have won national awards and have been printed in 14 counties, including Russia, France, Spain, Germany, Holland, Australia, Canada, Indonesia, India, Israel, Poland, Japan and China. Some of her best-selling titles have been "Best Party Book," "Games People Play," "Kids Party Book," and currently "Ladies' Night: 75 excuses to party with your girlfriends," "Rock-a-Bye Baby: 200 ways to help baby (and you!) sleep better," and her on-going mystery novel series called the Conner Westphal Mysteries. In her spare time she writes a weekly column in the "Contra Costa Times."

A Few Interesting Facts from previous Inaugurations:

March 4, 1793	George Washington	First Inauguration in Philadelphia; delivered shortest Inaugural address, just 135 words.
March 4, 1801	Thomas Jefferson	First Inauguration in Washington, D.C.
March 4, 1817	James Monroe	First President to take oath of office and deliver Inaugural address outdoors; ceremony took place on platform in front of the temporary Brick Capitol (present Supreme Court).
March 4, 1841	William H. Harrison	First President to arrive in Washington by railroad; delivered the longest Inaugural address (8,445 words).
March 4, 1861	Abraham Lincoln	Lincoln's cavalry escort to the Capitol was heavily armed, providing unprecedented protection for the President-elect.
March 4, 1897	William McKinley	First Inaugural ceremony recorded by a motion picture camera; first President to have a glass-enclosed reviewing stand.
March 4, 1913	Woodrow Wilson	Inaugural ball was suspended for the first time since 1853.
March 4, 1921	Warren G. Harding	First President to ride to and from his Inauguration in an automobile.
January 20, 1937	Franklin D. Roosevelt	First President Inaugurated on January 20th, a change made by the 20th Amendment to the Constitution; first time the Vice President was Inaugurated outdoors on the same platform with the President.
January 20, 1953	Dwight D. Eisenhower	Broke precedent by reciting his own prayer after taking the oath, rather than kissing the Bible; first time the JCCIC hosted the Inaugural luncheon at the Capitol.
November 22, 1963	Lyndon B. Johnson	First time a woman administered the oath of office (U.S. District Judge Sarah T. Hughes swore in Johnson on Air Force One).
August 9, 1974	Gerald R. Ford	First unelected Vice President to become President.
January 21, 1985	Ronald Reagan	January 20th fell on Sunday, so Reagan was privately sworn in that day at the White House; public Inauguration on January 21st took place in the Capitol Rotunda, due to freezing weather; coldest Inauguration day on record, with a noon temperature of 7°F
January 20, 1997	William J. Clinton	First Inaugural ceremony broadcast live on the Internet.
