


Branch Members on the Move Defending Women's Health

Defending Women's Health Care at the Supreme Court

In March, the Supreme Court heard arguments challenging employees' rights to health care plans that cover all necessary health services. As you may recall, the Affordable Care Act requires that qualified health plans cover preventive care without copay or cost-sharing, including contraception.

The court heard challenges brought by two for-profit companies — Conestoga Wood, a family-owned cabinetry business, and Hobby Lobby, a family-owned chain of arts and crafts stores. The companies claimed that providing certain services violates their religious freedoms and that they shouldn't have to provide employees insurance that covers this kind of health care. (It's recently come to light that Hobby Lobby's employee retirement fund has significant investments in a variety of companies that produce abortion and contraceptive-related products.)

People go to these businesses for cabinets and crafts supplies, not for religion. Yet Conestoga Wood and Hobby Lobby are trying to claim that the businesses themselves have religious rights and that those rights let companies control the private lives of their employees. That's a dangerous argument and would let employers have a voice in the health decisions of their employees. Who wants that?

The Affordable Care Act already ensures that religious rights are respected by exempting churches and houses of worship from the contraceptive requirement, and the law also gives religiously affiliated nonprofits the option to use a third-party insurer to provide coverage, thus ensuring that their own funds don't directly support the purchase of birth control. Hobby Lobby and Conestoga Wood do not qualify for an exemption — and they shouldn't. They are not religious enterprises, despite their owners' beliefs. Saying something doesn't make it so.

That's unacceptable and dangerous, and AAUW is committed to protecting employees' rights. AAUW signed on to several amicus briefs opposing the challenges to the Affordable Care Act's coverage requirement and signed on to a brief before the Supreme Court. We're also working with our allies on Capitol Hill to educate them about this issue. When it comes to women's health, we won't take anything for granted.

Highlights of the 2014 Awards Potluck

Our annual Spring potluck was held Saturday, May 17, at St. Andrews Episcopalian Church on Saratoga Ave. The program began with installation of new Board members and then we ate a delicious luncheon brought by members. There were several vivacious and helpful Tech Trek girls present, introduced by Blenda Mariani (Tech Trek chair). They spoke about their Tech Trek experience.

One of the highlights of this annual event is the opportunity to hear one of the recipients of a state or national AAUW award. We were very fortunate to welcome Kathleen Krenek, who is affilitated with *Next Door Solutions to Domestic Violence*. AAUW awarded Kathleen and her colleagues a one year Community Action Grant. She works with the Self-Sufficiency Program in San Jose.

Kathleen became executive director of *Next Door Solutions to Domes*-

tic Violence in July 2001. She brought with her 31 years of nonprofit leadership experience, with 16 years specifically in domestic violence prevention and intervention. Kathleen worked at the local and state levels; then she moved to the national level to work as director of the National Resource Center on Domestic Violence, where she led policy development, technical assistance to battered women's programs across the country, and research into causation and intervention strategies to eliminate domestic violence. She has written numerous papers dealing with topics including poverty/welfare reform, incarcerated battered women, battered women who kill, and the transformation of the battered women's movement that was published in 2001. A Special Note: Kathleen was pleased to meet one of our members, Joyce Sogg, who was one of the founding women of Next Door Solutions.

Local Scholarships have been presented to three young women. Diane Priest introduced one of the recipients, Jussely Morphin, who will be attending Berkeley in the fall. Morphin, a very capable and deserving woman, spoke of the importance of this award to her personally and professionally.

At the luncheon Blenda Mariani and Marlene Lamb, who have worked so hard with Tech Trek over the many years, were presented Named Gift Honors.

Blenda Mariani, a Bay Area native, came to SJSU to attend college and never left. After volunteering in her children's schools in Campbell, she worked full time for Addison — Wesley Publishing Company in Menlo Park and Hewlett-Packard in Cupertino, Mountain View and Palo Alto.


encouraging interest in science, math and engineering is especially critical for the younger girls — she feels that this program truly makes a difference.

Pineapple Coleslaw – Hawaiian Style

Nancy Hobbs, our recently passed member, brought this wonderful and simple Pineapple Coleslaw to last year's Grant Awards Potluck. Nancy, a founding member of the 40+ year old Gourmet Group, could be relied on to bring tasty and delicious treats. Make this unusual Coleslaw this summer in remembrance of Nancy Hobbs and all the work she gave to Tech Trek and to Los Gatos-Saratoga AAUW. I found this Coleslaw easy to make and very popular when taken to barbecues.

MAKES: 8 to 10 servings

1 small head (about 1 pound) green cabbage, cored and shredded

- 2 small carrots, peeled and shredded
- 2 small cans (8 ounces each) crushed pineapple, with all the juice
- 2 tblsp. red wine vinegar or cider vinegar (optional)

Salt and pepper, to taste

1 tsp. poppy seeds (to garnish)

- 1. Combine all the ingredients. Taste and adjust seasonings. Cover and refrigerate until ready to serve.
- 2. Sprinkle with poppy seeds and toss to combine. (Can be made a few hours before.)
