Susan served on the President's Committee on Trade Policy, under President Clinton, and was the first woman to chair the panel. She has also served on the Lucille Salter Packard Board of Directors, the Smithsonian Institute's Board of Trustees and was the CEO of the Synopsys Outreach Foundation.

A Letter From AAUW Executive Director

Dear AAUW Friends:

Today I was honored to attend the national ceremony celebrating President Abraham Lincoln's 200th birthday. As you can imagine, it was a wonderful event - held in the grandeur of the U.S. Capitol Rotunda, but tempered by the real challenges before us. The crisis facing America today is very different from the one that faced President Lincoln, but as President Obama stated this morning, "We are once again debating the critical issues of our time. Let us remember that we are doing so as servants to the same flag, as representatives of the same people, and as stakeholders in a common future." Those words get to the heart of AAUW's mission, and specifically what AAUW has been doing to get our nation back to work and our economy moving again.

As the recession has deepened, we at AAUW have been stepping up our efforts to fight for working women and their families. I wanted to take this moment to fill you in on our latest work, update you on our progress, and keep you informed on where we stand on these critical issues.

For the last several months, AAUW has been lobbying members of Congress on our top priorities for the American Recovery and Reinvestment Act - the recovery bill -which include investments in higher education, school construction and modernization, affordable healthcare, targeted tax credits, and direct appropriations to states and localities to support critical services. The recovery package, a version of which has been passed by both chambers, has now been reconciled and is set for a final vote. This week. AAUW sent a letter to conferees urging them to include our most important priorities in the

final bill. We are pleased to report that AAUW was successful in maintaining most of our key priorities in the compromise measure, including:

- A valuable tax credit to "Make Work Pay" for American families and an expansion of the Child Tax Credit to target more families in need - especially those in poverty.
- The inclusion of an extension and increase of current unemployment benefits, which will help many hurting workers facing an even tougher job market and also represents funds that will quickly go back into the economy.
- Almost \$20 billion in appropriations for the Supplemental
 Nutrition Assistance Program
 (SNAP) because, in addition to
 feeding the hungry, food stamps
 are dollar for dollar by far the
 most stimulative provision in the
 recovery and reinvestment bill.
- \$53.6 billion in State Fiscal Stabilization Funds to help schools maintain their education budgets and initiate critical renovation and construction projects. This education funds will save jobs as well as create them.
- The "American Opportunity Tax Credit," a \$2,500 tax credit for college tuition and other expenses, providing a targeted investment that will encourage individuals to retrain and retool through higher education - which will in turn improve their earning potential and career competitiveness. People without college degrees are much more vulnerable to being laid off than those who have this important credential, providing further evidence that the AAUW priority of investing in education is money well spent, period.
- A vital increase in the maximum



Pell grant award of \$500 for the 2009-2010 school year, as well as additional funds for work-study programs, helping millions of students go to college - and stay in college.

 Providing meaningful COBRA subsidies, which will allow more American families to be able to maintain their health insurance and afford valuable preventative care after they've been laid off, which could help to avoid not only heartache but bankruptcies in the future.

I wanted to give you a complete update on our economic recovery efforts, and that can't be done in a short note. But since I know that our members expect and deserve an AAUW that fights the good fight on multiple fronts, never resting until the job is done, I thought I would use the auspicious occasion of Lincoln's birthday to illuminate our efforts. AAUW is steadfastly working towards a more perfect Union, and your support and participation is what makes this success possible. Thank you.

Sharon Kelkenberg acted as the waiter taking the orders. Even I was able to order in Spanish although my Spanish skills are very limited.

Bernie Fawley related an anecdote from the holidays, entirely in Spanish. I was very impressed. Several other women were able to speak about topics other than food, too. If you would like to improve your Spanish, this is the group for you. Sharon Kelkenber g or Helen Lemmon can give you more information. They are very for giving, but insistent on speaking Spanish so it is a great opportunity to learn.

Health Care Legislation Report from the Independent Women

One of our members, Barbara Lea, spoke to us on "Health Care Legislation in California and the Nation." Barbara has served on the League of Women Voters State Health Committee for the last five years.

She began our meeting by stating that the United States is the only developed country that does not have a universal health care plan. Over onehalf of the bankruptcies in this country are caused by out-of-control medical bills.

Barbara favors a single-payer medical plan similar to Medicare where we have controlled billing but are able to choose our own doctors.

Currently there are two bills – one in the House and one in the Senate. In these two bills there are several proposals to control medical costs. Following is a composite list of proposed reform in the two bills. They are not necessarily in both bills – some are in one or the other.

- Introduce new technology and new ways to organize work
- · Simplify medical forms.
- Provide electronic medical records.
- Prevent medical errors and duplicate testing.
- Pay doctors for the quality of services rather than the quantity.
- Increase oversight against fraud.
- Set up an independent commis-

sion to expand new ideas and drop bad ones.

- Establish a public option.
- Compare treatments to see which are most effective.
- Negotiate drug prices.

Neither bill has a provision for malpractice reform. The Senate bill provides no public option, but the House bill does.

The AARP has thrown its full weight on supporting health care reform.

Barbara has a link, which compares the major provisions for each bill. Please email her to send it to you if you are interested.

California

Previously, the Legislature in California twice passed a single-payer bill, HR840, which was vetoed by the Governor.

Mark Leno has introduced a similar bill, HR810, which has passed the Senate and is winding through the legislative process. It is scheduled to be voted upon by the assembly by August 31st.

Talbot became Dean of Women at the University of Chicago; and Richards was the first female student and instructor at

the Massachusetts Institute of Technology (MIT), and the first woman in America to earn a chemistry degree.

For 125 years, AAUW has shaped the social, political, and economic scene for women, including the fight for pay equity; a woman's right to vote; and legislation that protects women at home, in schools, and in the workplace. AAUW continues to advance equity for women and girls through advocacy, education, and research.
