History of the South Bay's Railway Service – 1904 to 1963 (to Palo Alto in the north, to Saratoga in the west, to Los Gatos in the south and to Alum Rock Park in the east)

#### **AAUW Keynote Speaker**

The Interurban Railway, yearn for the days of a trip by rail to San Jose or Palo Alto on the sleek Interurban Railway? The mass transit train, carrying packages and people, once quietly traveled the Santa Clara Valley.

Ray Cosyn is a spokesperson on the history of America. He has an Engineering Degree from the University of Illinois and a Masters Degree in American History from San Jose Sate University. He has spoken to numerous groups on a wide range of topics from the Civil War, through and including WWII. Mr. Cosyn is on the board of directors of the Saratoga History Museum and sits on committees focused on integrating bicycle transit into our transportation infrastructure.

#### Los Gatos and Saratoga Railway

Before the days of \$4 gasoline, congested highways, and polluted air, there was a time when a commuter could travel inexpensively from one place in the South Bay to another on a clean fast electric interurban railroad. Believe it or not, Los Gatos and Saratoga had the Peninsular Interurban (PI). It was part of this transportation happening that took off prior to Henry Ford rolling out his Model T and the Wright Brothers being able to demonstrate sustained flight.

At the turn of the 20th century the South Bay was an agricultural area crisscrossed by a network of dirt roads and without exception the horse was king. By the turn of the century, the cities of San Jose and Palo Alto had installed electric streetcar systems but travel outside of the metropolitan areas was primarily by horse. A new solution was required which

# Partisanship in Congress Stops Progress on Issues

Rather than deal with the pressing issues facing the country such as continuing high unemployment, Congress has been focusing on the debt ceiling. Many members are demanding major cuts in all aspects of the federal budget, including entitlement programs such as MediCare and Social Security, as a condition for approving an increase in the debt ceiling. Little to no study has been made on the longer-term implications of the cuts being proposed. In the absence of a well-thought-out plan, it is frightening to consider the consequences of these hasty decisions.

Of particular concern to AAUW are potential changes to Social Security, such as reduction or elimination of benefits and the potential of privatization. Protecting and strengthening Social Security, one of our nation's best antipoverty programs, is particularly important to women.

All AAUW members should be concerned about the partisanship that is so divisive both in California and in Congress.

In early May, you will receive an email from Vote-now with your access code and a link to the voting site. # **AAUW Releases State-By- State Rankings for Equal Pay**

D.C. Has Best Ranking, Wyoming Worst

WASHINGTON – With the release of *The Simple Truth About the Gender Pay Gap*, the American Association of University Women (AAUW) unveiled new state-by-state equal pay rankings. Updated for the national observance of Equal Pay Day, which marks how far into the current year women must work to match what their male counterparts earned last year, *The Simple Truth* charts the wage gap in the 50 states and the District of Columbia.


The wage gap is narrowest in the nation's capital, where women have the best earning's ratio — 91 cents, on average, for every dollar earned by their male counterparts. The state with the worst earnings ratio is Wyoming, where women make 64 percent of men's earnings. The national average puts women at just 77 percent.

The wage gap costs working women and their families tens of thousands of dollars in lost wages and directly affects women's retirement security. These numbers are worse for women of color. White and Asian women earn, respectively, 82 percent and 88 percent of white men's earnings. African American and Hispanic women earn much less — just 70 percent and 61 percent of what white men earn, on average.

"Equal Pay Day, which this year falls on April 17, is an unfortunate reminder of how far we have to go to reach true pay equality. The wage gap hasn't moved significantly in nearly a decade, and at this rate, we'll be marking Equal Pay Day for the next 60 years," said AAUW Executive Director Linda D. Hallman, CAE.

In addition to the release of *The Simple Truth*, AAUW branches across the nation will mark Equal Pay Day by holding rallies, wearing red to symbolize that women's wages are in the red, handing out Pay Day candy bars, and hosting bake sales with discounts for women.

"The gender pay gap is unlikely to go away on its own. Our publications and tools will empower our advocacy on behalf of women and their families," said Catherine Hill, AAUW director of research. "The Simple Truth is a useful resource for women, the media, and society at large as we work to address this stubborn inequality."



# **Connection Today – Peninsula Inter-Urban and VTA Light Rail**

would bring country folk to the city and allow city dwellers to not only travel between cities in minutes, but also provide them with ready access to the country. The scene was set for the beginnings of the Peninsular Interurban (PI).

The PI, which was headquarter in San Jose stretched from Palo Alto in the north, to Saratoga in the west, Los Gatos in the south and to Alum Rock Park in the east. One could board a car in Saratoga and travel to Palo Alto, San Jose, or Congress Springs with service being on the half hour over mainly a single-track line that radiated out in three directions from Saratoga. A picnic at Congress Springs, a football game at Stanford or a doctors appointment in San Jose could all be reached using the PI.

The Peninsular Interurban (PI) began operation in 1904 and ended service in 1934. In 1910 the PI purchased a group of 15 cars from the St. Louis Car Company and when the Great Depression hit were transferred these cars to Pacific Electric (PE), which carried on service until 1963.

The PI provided hourly service in each direction on the line. The fares were quite reasonable for their time and attracted fairly high ridership up to the end of WWI. During their peak years, a passenger could ride from Palo Alto to San Jose for fifty-five cents or ten cents between adjacent stations. In order to generate ridership during off peak periods, the PI built a spur line to Congress Springs, which is just west of Saratoga and provided a grand place to have a picnic in the shadow of the Santa Cruz Mountains.

"What Comes Around – Goes Around". The VTA's light rail system is a reincarnation of the PI. Its routing varies from the original PI route in order to serve a different set of demographics; however, the technology is much the same. The VTA's system began life in 1984. The VTA line has some of the same problems that haunted the PI during its life; the major one being inadequate revenue to cover operating expenses and to service the debt. The difference today is that the VTA is a government funded and run operation (the PI was a privately held and run enterprise). The VTA can run at a deficit while the PI could not. This is not to say that the light rail line is a mistake because VTA ridership continues to increase. In the future, we will not be building more roads in the South Bay because of air quality and since land is not available. Given these constraints, VTA's investment in light rail is a sound one. It is unfortunate that we allowed the PI to expire before it had a chance to meet today's requirements.

### Update on a Host of Issues that AAUW Avocates About

#### Study: Most Low-Wage Workers Lack Access to Employer Insurance Coverage

A new report from the Center for Economic and Policy Research at Georgetown University found that only 26 percent of low-wage workers—defined as those in the bottom 20 percent of hourly wages—received health insurance through their employers in 2010. In addition, the rate of low-wage workers who are uninsured rose from 16 percent in 1979 to 39 percent in 2010. The report notes that if the new health care law, the Affordable Care Act, is repealed, the coverage rates for low-income Americans will decline even further.

AAUW believes that everyone is entitled to health care that is high quality, affordable, and easily accessible. AAUW is hopeful that the health care law will substantially improve a system that has not worked as well as it needs to for far too long.

### **Census News: Bachelor's Degree Being Earned in Higher Numbers**

Bachelor's Degree Attainment Tops 30 Percent for Adults 25 and Older Census Bureau data released this week revealed that for the first time ever more than 30 percent of adults in the United States have at least a bachelor's degree. In 1998, not even 25 percent of a comparable population held bachelor's degrees. According to the data, the number of women with bachelor's degrees has increased by 37 percent over the last decade. Of the 61 million people older than 25 who hold bachelor's degrees, 30 million were men and 31 million were women.

AAUW advocates increased support for and access to higher education for women and other disadvantaged populations. Even in these difficult economic times, it is critical that we invest in higher education, which is the most direct route to innovation, job creation, and long-term economic selfsufficiency.

### **Contraception Debate Ongoing at National, State Levels**


Georgetown Law student Sandra Fluke's voice was heard this week after she was denied an opportunity to speak last week at a hearing on birth control hosted by House Republicans. Fluke was scheduled to be the Democrats' only witness—and the only woman on the panel—but was left off the panel after oversight committee leaders called her unqualified.

As a result, AAUW brought in Fluke for a public forum Wednesday on access to birth control, and House Minority Leader Nancy Pelosi (D-CA) hosted a hearing on women's health Thursday where Fluke was the only witness to testify. Pelosi said during the hearing, "It's amazing what lengths they [Republicans] will go to in order to not hear the voice of women."

#### Lawsuits Filed Against States Seeking to Limit Access To Reproductive Health Care Coverage

This week, seven states filed a lawsuit against the federal government's requirement that religious employers offer health insurance that includes contraceptive coverage. The seven states involved in the lawsuit are Nebraska, Michigan, Ohio, Oklahoma, South Carolina, Florida, and Texas.

AAUW has long believed that politicians should not insert themselves into the reproductive health care decision-making process and supports the right of every woman access to safe and comprehensive reproductive health services. AAUW and The Coalition to Protect Women's Health Care oppose any measure that attempts to restrict or limit the regulation on preventive care services and contraceptive coverage.
