Study Topics Just Released - Great Decisions 2015

Great Decisions is a program created by the Foreign Policy Association (FPA). Great Decisions are sponsored locally by the League of Women Voters (LWV), the American Association of University Women (AAUW), the Saratoga Area Senior Coordinating Council (SASCC), and the Saratoga Retirement Community (SRC).

The topics for this year's eight sessions are:


- Russia and the Near Abroad
- Privacy in the Digital Age
- Sectarianism in the Middle East
- India Changes Course
- U.S. Policy Toward Africa
- Syria's Refugee Crisis
- Human Trafficking in the 21st Century
- Brazil's Metamorphosis.

Last year over 60 people participated in the two separate groups.

(Group 1) eight bimonthly sessions held on the first and third Thursdays of each month from 1:00 to 3:00 pm in SASCC's Modular Oak and Magnolia classrooms. Group 1 will be led by Al and Anne Stewart who will serve as Program leaders also. Thursday, February 5, 2015 will be the first study session.

(Group 2) weekly sessions for eight consecutive weeks from 2:00 to 4:00 pm at the SRC, Barnes Hall. Group 2 will be led by Rosalie Price who also serves as program coordinator for that group. Thursday, February 5, 2015 will be the first study session.

NOTE: For Group 1 participants only there will be an organizing meeting on January 29, 2015 at 1:00 pm in the SASCC's Oak classroom, to distribute course materials and select volunteers to serve as individual



topic leaders. Two leaders will be required for each topic to facilitate Group One breaking groups to enable greater individual participation in group discussions. (We are expecting 40 participants like last year.)

Early signups for the coming season's program are encouraged. The <u>absolute</u> sign up deadline is November 30, 2014, even though the first of the eight sessions will not begin until February 5, 2015. That deadline is necessary to ensure the receipt of new program workbooks and DVDs from the FPA in time to insure their timely distribution to participants.

The registration fee is \$30 per individual and \$40 for couples who share a workbook. (An increase of only \$2.50 over last year's prices.) Checks should be made payable to *Rosalie Price* and mailed to her at 14500 Fruitvale Ave, #6110, Saratoga, CA 95070. It is important that you note on your check in which of the two groups listed you wish to participate.

Update – Committee on Homeless Women & Children

With the *Georgia Travis Center* closing, we sought other resources for homeless women and children.

One program is *Grace Community Center* at 10th St. and San Fernando in San Jose. They have the only shower program for homeless women in San Jose area. (They take donations of clothing and household items. Hotel toiletries and new or gently used towels are always needed.)

Another program is "Be a Dear and Donate a brassiere". They collect new and slightly used bras and take them to facilities and programs that serve homeless women. I went to one of their sorting meetings. They receive bras from all over (California, entire United States, Australia, Japan, etc). If you have bras to donate you can contact Pat Khan or JoAn Lambert.

Several women in the area are confident that they will be able to open a program that will provide services for homeless women. The proposal is very similar to the *Georgia Travis*Center with the exception that there will be no services for children. It is called "The Women's Gathering

Place". We will follow their progress and support them any way we can.

Human Trafficking Action!

Tell Governor Brown to sign SB 477

Slavery has been illegal in the United States for 149 years. Despite this, illegal forced labor and human trafficking still persists, with over 2,400,000 victims of human trafficking worldwide.

Traffickers prey on those who suffer most from macro factors like gender discrimination, family violence, and a lack of access to education and economic opportunity. Although some are forcibly taken into the United States, many are lured here with the promise of a well-paying job and a chance at improving their lives and those of their families. They arrive, only to find that the



promised job doesn't exist and they are now in the human trafficker's control.

SB 477 takes a three-pronged approach to this problem: Contractors using foreign labor must register with the state,

- cannot change the terms of a contract without enough notice to the workers
- cannot charge them various "visa" or "processing" fees
- cannot claim that a job is available without actually hiring the foreign worker brought in for that job.

This brief summary is a continuing effort to keep the members appraised of discussions, proposals and decisions made during the Board Meetings.

Audry Lynch Wins Award at Hollywood Book Festival

Honor felt like a mini Oscar evening for writers

Last month Audry Lynch, 81, was honored at the *Hollywood Festival of Books* in Los Angeles on July 26 for her book which shines a spotlight on the movie stars of "*bygone age*". Lynch accepted the award for her book in the biography and autobiography category. The ceremony was held in the Academy Room at the Roosevelt Hotel.

In The Rebel Figure in American Literature and Film, Lynch reveals an interconnection between movie star James Dean and novelist John Steinbeck. This latest book looks at how the lives of Steinbeck, Dean, and directory Elia Kazan intersected on Kazan's East of Eden, based on Steinbeck's 1952 novel. The movie catapulted all three to fame. The book also traces similarities between Steinbeck and Dean, the main ones being that both were college dropouts who hailed from small towns and conservative families. Dean and Steinbeck both disliked their hometowns and left at the age of 18, but were buried there upon their death.

Lynch has a 40-year "passion for the writing" of Steinbeck and has made him the focal point in two other books, Steinbeck Remembered and With Steinbeck in the Sea of Cortez.

Lynch is a member of the California Writers Club and the National League of American Pen Women. She is working on a book about Mark Twain and his travels to Bermuda, where he is considered a rock star, she said.

Lynch is a graduate of Harvard University, Boston University, and the University of San Francisco, where she earned her Doctorate Degree. Before committing her life to writing she served as a guidance counselor for 32 years and taught English at Mission College (in Santa Clara) for 25 years. Lynch has lived in Saratoga since 1970.

AAUW LAF Supports Sex Discrimination Suit

Former University of Tennessee athletic department professional allege unequal pay practices, retaliation

The AAUW Legal Advocacy Fund (LAF) announced today that it will provide support to the plaintiffs in *Moshak v. University of Tennessee,* a case that underscores the everyday nature of gender discrimination in college athletics.

The lawsuit was filed in 2012 by Jennifer Moshak, Heather Mason, and Collin Schlosser, former employees of the University of Tennessee's women's athletics department. The plaintiffs allege sex discrimination and unlawful retaliation under Title VII of the Civil Rights Act of 1964, Title IX of the Education Amendments of 1972, and the Equal Pay Act of 1963. They claim they were unlawfully discriminated against and eventually forced out of their positions during a university-led merger of the men's and women's athletic departments.

Schlosser and Mason argue in part that they were fired by UT after making internal complaints alleging unequal pay between the men's and women's athletic departments. Moshak claims she was forced to retire after being demoted and marginalized. The plaintiffs also say that during the merger, which was led by newly hired Athletic Director Dave Hart, the vast majority — 86 percent — of positions terminated either were held by women or were associated with the women's athletic department.

"This case is an opportunity to grapple with some of the gender gaps still at play in university athletics," said AAUW Executive Director and CEO Linda D. Hallman, CAE. "We are proud to stand with these plaintiffs in their fight for fairness. Their claims shine a light on why AAUW does this type of work, day in and day out." The case is currently scheduled to go to trial in June 2015 in the U.S. District Court for Eastern Tennessee.

"The University of Tennessee and its Athletic Director, Dave Hart, engaged in blatantly discriminatory and retaliatory actions against accomplished employees in the women's athletic department, in violation of Title IX and other federal laws," said the plaintiffs' attorney, Lisa Banks, of Katz, Marshall, and Banks, a civil rights law firm in Washington, D.C. "Gender discrimination is unfortunately a situation that is all too common in collegiate athletic departments across the country today, and we intend to use all the tools at our disposal to hold the university accountable and to shed light on this pervasive problem."

The AAUW LAF has been crucial to the success of many gender discrimination cases during its 33-year history. The case support program provides financial and organizational backing for plaintiffs challenging gender discrimination in education and the workplace.
