

John Steinbeck (*East of Eden*). Fun entertainment like *Major Pettigrew's Last Stand* by Helen Simmonson, and *Minding Frankie* by Maeve Binchy.
We've read mysteries like *Bruno*, *Chief of Police* by Martin Walker.
For literary enthusiasts *State of Wonder* by Anne Patchett was fascinating.

Current nonfiction like Medicine's Ten Greatest Discoveries by Gerald Friedland, Letters to the Valley: a Harvest of Memories by David Mas Masumoto, The Fiddler in the Subway by Gene Weingarten and The Happiness Project by Gretchen Rubin has given us a lot to think about.

Historical biography *Isabelle of Spain: The Last Crusader* has been enlightening about a woman's courage and leadership abilities.

#### **General Meeting Speaker – Barbara Spector**

Barbara Spector is a Council Member for the Town of Los Gatos. Barbara has also served as Mayor of Los Gatos.

In 1973, Barbara settled in Los Gatos with her husband, Ira, and quickly became involved in community issues. She was a member of the Los Gatos Planning Commission between 1980 and 1988, often serving as either Chair or Vice-Chair. During her tenure, the Commission developed new zoning ordinances, the Hillside Plan, the Downtown Specific Plan, and a revised General Plan to protect our hillsides, historic homes, neighborhoods and local businesses.



Barbara is a native of Northern California and grew up on a farm in Stockton where she went to the same one-room school house that her father had attended.

Formerly a high school English teacher, Barbara has been an attorney for 30 years. She served as Special Counsel to the law firm of *Hoge, Fenton, Jones & Appel* where, in addition to her civil litigation and mediation practice, she was regularly appointed by state and federal courts to resolve disputes without trial as a judge pro tem, a special master, a judicial arbitrator and a mediator. For three years, she had been selected by her Northern California colleagues as a "Super Lawyer." In 2003 Barbara's volunteer services to the legal profession and the community earned her the Bar Association's highest honor, *the Bryl Salsman Award.* 

All that she does for Los Gatos is a product of the passion she has always had for our community as reflected in the following *Sunset* magazine passage written in 1915: "To see Los Gatos is to love the town. To enjoy the privilege of a few days' or weeks' stay within the gates of that beautiful city of 3,500 souls is to wish to come again. And to become a permanent resident there is to lie in paradise, if such there be on this earth."

Though one of her most appalling ideas was that we would open a daytime drop-in center in downtown San Jose for homeless women and children. A few of the doubtful questions:

- Where would the money come from?
- How many hours were we expected to work there?
- Where would it be housed?

We really didn't know Georgia that well yet. She made it happen, of course, along with all the other projects (a Standford Study on Homeless, letters and visits to lawmakers, to name just two). This woman was a Quaker, she practiced silence at their meetings, but nowhere else!!!

At our June potluck our Committee on Homeless Women and Children voted to continue even with the loss of those members resigning and the passing of Penny Sink. Our ten active committee members are: Nancy Anderson, Chair, Patty Weber, Treasurer, Marlene Lamb, Recording Secretary, Charlene Burger, Nancy Christensen, Sharon Kelkenberg, Pat Khan, JoAn Lambert, Ann Roberts, and Sumi Tanabi.

#### **Great Decisions 2012 Coming Up Soon!**

It is time to mark your calendars and sign up for *Great Decisions 2012*. Early sign-ups for the coming season's program are encouraged. There will be only two groups this year.

The topics for this year's eight sessions are:

- Middle East Realignment
- Mexico
- Exit from Afghanistan and Iraq
- Indonesia

- Promoting Democracy
- Cyber Security
- State of the Oceans
- Energy Geopolitics

The registration fee is still only \$25 per individual and \$35 for couples who share a workbook. Checks should be made payable to Rosalie Price and mailed to her at 14500 Fruitvale Avenue, Cottage # 6110, Saratoga, CA 95070. It is important that you note on your check in which of the two groups listed below you wish to participate.

The sign up deadline is November 30, 2011. That deadline is necessary to ensure the receipt of new program workbooks and DVDs from the Foreign Policy Association (FPA) in time to facilitate their distribution to participants.

The two separate groups to be formed this year will meet as follows:

**Group 1** – eight bi-weekly sessions held on the first and third Thursdays of each month from 1:00 to 3:00 pm in SASCC's Modular Classrooms. *The first session begins on February 2, 2012.* 


There will be an organizing meeting on January 26, 2011, for Group 1 participants only, in the SASCC classroom to distribute course materials and to identify volunteers serving as individual topic leaders. Group 1 will be led by Al and Anne Stewart who will also serve as program leaders.

**Group 2** – weekly sessions for eight consecutive weeks from 2:00 to 4:00 pm at the SRC. *The first session begins on February 2, 2012.* 

Group 2 will be led by Rosalie Price who also serves as program coordinator for that group.

*Great Decisions* is a program created by the Foreign Policy Association (FPA) and sponsored locally by the League of Women Voters (LWV), the American Association of University Women (AAUW), the Saratoga Area Senior Coordinating Council (SASCC), and the Saratoga Retirement Community (SRC).

#### **Work-Life Balance**

Healthy Families Act (S. 1152) Cosponsorship. The Healthy Families Act (S. 1152) would provide accrued paid sick and safe days for many employees nationwide. It would require employers with at least 15 employees to guarantee workers seven days of paid sick leave annually. In addition, these paid sick days could be used for treatment, recovery, and activities necessary to deal with an incidence of domestic violence.

By ensuring that hard-working Americans have access to a minimum number of paid sick days, which can also be used to care for sick dependents, this legislation would mean that employees no longer have to choose between caring for themselves or loved ones and losing much needed income.

The legislation was originally introduced by Sen. Edward M. Kennedy (D-MA) on May 21, 2009. Since Sen. Kennedy's passing, the bill has continued under the leadership of Sens. Chris Dodd (D-CT) and Tom Harkin (D-IA). At the time the Congressional Voting Record went to press, the bill had 24 co-sponsors.

#### Without Pell Grants College Will Be Out of Reach for Millions

Pell Grants — which help more than nine million students afford college — are facing massive cuts. The students who receive these grants, disproportionately women and minority students, are at risk of being among the victims of Washington's current budget battle.

Cuts to Pell would not only devastate the futures of the students who rely on it, but also our economy, which desperately needs more college-educated workers to rebound. Pell Grants and other federal tuition assistance constitute a direct investment in the future and long-term economic strength of our country.

Today, the American Association of University Women (AAUW) and our allies across the country are standing up in support of Pell Grants. We're making sure Congress understands that cuts to Pell would hurt millions of Americans and weaken our economy moving forward.

Tell your members of Congress that slashing Pell is not an option. Tell them why higher education matters and why denying it to millions of women and minority students will undermine the economic recovery.

# AAUW Legalative Watch

AAUW has supported eight Congressional issues this year as part of the Public Policy agenda. They are: (1) the Ledbetter Pay Equity Bill, (2) Paycheck Fairness Act, (3) Economic Security, (4) Paid Sick Days, (5) DC School Voucher, (6) Hate Crime Prevention, (7) Sotomayer Confirmation and (8) International Family Planning. Our representatives were mostly supportive of these issues.

Efforts to reach people on these AAUW issues: Barbara Boxer and Mike Honda scored 100%, Anna Eshoo scored 89% and Diane Feinstein scored 63%.

Major funding reductions are already in the governor's budget, particularly affecting women, children, disabled persons and the elderly. The deadline for getting tax extensions on the June ballot has passed. A May revision to the State Budget will call for severe cuts to Education, in the magnitude of \$5 billion.

AAUW members and friends need to immediately let all legislators, and especially Republicans, know that we place a high priority on Education, and support the Extension of Temporary State Taxes. Please send a message to your legislators NOW!
