Tech Trek

The Tech Trek Committee thanks those members who have supported sending middle- school girls to science camp with donations when paying their dues and the Games Party.

We now have almost enough to send 4 girls to camp next year.

This year we sent 5 girls to Stanford Tech Trek Science Camp. Some of the Tech Trek Chairmen from the various Northern California Branches were invited to spend a morning at Stanford. What a great experience! We observed the core classes in session. We sat in on the staff meeting while they planned the evening meeting of the girls with the 7 or 8 professional women and also showed the material for the girls' thank- you notes.

We will have a short DVD at our September meeting that one of the councilors made at camp this year. It will show our Branch campers and as well as a junior leader. It will show LaDoris Cordell, the inspiring keynote speaker. The camp picture in front of Encina Hall, a tradition, a trip around campus, core classes which cover cellular biology, molecular biology separating out the DNA of sickle cell anemia, robotics class, eye dissection, veterinary medicine, CSI-forensics, Astronomy, and Math/Geometry/Design learning about designing a house and its cost, and a Marine biology class where they face squid dissection. The Wet Sponge Battle was repeated this year even though it was not nearly as hot as last year. A person from Pixar comes each year to demonstrate how a latest Pixar movie was put together. Professional Women's Night had an inorganic chemist, paleoclimatologist, architect, grad student in immunology, environmental engineer and Coast Guard Lt. Commander, gemologist, and a cellular biologist. Note that on the video is a physicist from the Stanford Linear Accelerator Center, and three dorm moms, a psychologist, therapist, and medical editor.

Activities which are not in the Video are the Marine Science Institute boat trip, The Bat Lady, and the trip to tour the Cantor Art Museum on campus, a highlight with the special exhibit of the Tuareg art and crafts. They were able to swim in the Stanford swimming complex and to see the sport museum. From Stanford's Financial Aid office, an AAUW member talked of How Anybody Can Finance a College Education.

A Tech Trek camper will be at the September meeting to talk about her experiences and the thank- you notes will be available for members to read.

Comprehensive Sex Education


The U.S. House passed legislation that makes important changes to the federal abstinence-only program. Democratic leaders included the provision in legislation to extend and expand the State Children's Health Insurance Program (SCHIP) that was passed by the House by a vote of 224-204. The provision will dramatically increase the ability of states to use federal funds to offer more comprehensive sex education programs.

Under the new provision, states will have the flexibility to define abstinence education more broadly than has been allowed in the past. At the same time, it will require that programs be medically and scientifically accurate and that they be based on a model that has been proven effective at reducing unintended pregnancy and the spread of sexually transmitted diseases.

Finally, it will end the automatic funding status of the Title V program. For the past decade, \$50 million was provided annually without having to go through the usual appropriations process that allows for regular scrutiny. It amounted to an entitlement for states — although many states currently refuse to accept the funds because of the requirements that the money be used for programs that meet a strict ideologically driven definition.

There is a long way to go, and the President has threatened to veto the expansion of SCHIP, but the House action is an important step in improving a program that has, for far too long, failed to give young people the information they need to make healthy decisions. Under the new provision — if it becomes law states will be able to direct funds to programs that can actually help young people. No longer will taxpayer dollars be used to fund programs that provide young people with misinformation. That is an enormous victory for American youth and everyone concerned about the impact that teen pregnancy has on individuals, on families and on our communities.

Attention: Spanish Speakers

Following the suggestions of some of our new members last winter, our branch started a Spanish Conversation Group, chaired by Helen Lemmon, which meets twice a month.

Having taken a few Spanish conversation classes, I decided to join the group. Much to my chagrin, I had forgotten most of what I had learned so I signed up for a class given through the Los Gatos Parks and Recreation Department, "Spanish During the Day".

Senora Mirta Luque, a native of Argentina, is teaching the class In Argentina she was a Spanish/ English translator and an interpreter for the United Nations. I have taken many language classes over the years but this class is by far the best I have ever attended. Senora Luque has structured the class to get us involved in speaking the language practically from the first day. In addition to the language, she is teaching us the culture of Spain and Latin America.

Ledbetter Fair Pay Act

Thanks to the hard work of AAUW members and other coalition partners, the Lilly Ledbetter Fair Pay Act (H.R. 2831) was passed (225-199) in the House on Tuesday, July 31. Introduced in response to the U.S. Supreme Court's recent decision in the *Ledbetter v*.

Goodyear case, this bill clarifies that each discriminatory paycheck is in fact another act of discrimination. In doing so, H.R. 2831 restores the law to the way it was previously applied, and ensures that victims of pay discrimination can have their day in court. On Friday, July 27, the White House threatened to veto the bill.

While the passage of this bill is a positive step for those who experience wage discrimination, it will merely ensure that the Title VII statute of limitations is enforced the way is had been in the past. It does not move us forward on the path to pay equity, which means our work is far from done. AAUW strongly supports the **Paycheck** Fairness Act (H.R. 1338/S. 766), which would expand upon the original scope of the Equal Pay Act of 1963 by closing loop holes and improving the law's effectiveness. While this bill is cosponsored by a majority of the representatives in the House (224) and has been the subject of two House committee hearings, it is currently stalled in the House Education and Labor Committee and is not yet scheduled for a mark up. This is a critical step in moving the bill forward to a vote on the floor.

AAUW Phoenix Convention

Dear Branch Members:

Thank you for letting me represent you at the Association convention which was held on June 29-July 2, 2007. As I learn more about AAUW's programs in research, public policy, legal advocacy, and grants and scholarships, my pride in AAUW membership continues to grow.

A great number and variety of excellent speakers and workshops were offered on the themes of:

- 1. action for equity
- 2. economic empowerment for women
- 3. global perspectives, and
- 4. uniquely AAUW issues of concern in our program planning.

Summaries of convention presentations can be found on the Association website, www.aauw.org.

I attended presentations and workshops in each of the above areas. Following are a few facts that impressed me. One of the keynote speakers, Greg Montenson, founded a non-profit organization to fund education, especially for girls in remote, mountainous areas of Afghanistan and Pakistan where the literacy rate is only 5% and even less for girls. He believes peace is built upon hope and the education of girls and he has built more than 60 schools with modest amounts of money. He found that it costs less than \$1.00 per child per month to operate schools in this area.

He said the Taliban stepped in and set up camps and radical Islamist schools when US aid stopped following Pakistan's destructive earthquake. He believes that educating women will be a force against violence in these countries, stronger than bombs, roads, and electricity and that the US should invest more in education there.

Workshops were also given on the Virginia Gildersleeve International Fund, www.vgif.org ,which also funds education and assistance to women and girls in third-world countries and One Shared World (see information on the AAUW website).

Statistics were presented at a workshop on work force development in the United States that demonstrated that:

- 1. Only 42% of the US workforce 25 years and older, has completed at least a high school diploma.
- Women often choose careers in lower paying fields such as childcare, health care and education.
- 3. When women study or train in male-dominated fields such as engineering, biological sciences, or the construction trades, they earn 60-75% less than their male colleagues.
- 4. Sixty percent of low-wage earning households are headed by women.
- 5. Forty seven percent of femaleheaded households are below the poverty line.
- 6. There are currently 13.6 million single mothers.

Solutions recommended were:

- 1. Invest in math and science education for all grade levels, vocational education and post secondary education to prepare for the technical jobs business and industry need.
- 2. Re-establish federal programs which encourage and fund training for women in higher paying fields.
- 3. Create career ladder programs in traditionally female-dominated fields, i.e. nursing.
- 4. Encourage girls to learn the cost of living (WOW website) and study prevailing salaries in

- various careers. Check the website hotjobs.
- 5. Working women should check how their salaries compare to others in similar jobs. Websites are *vault.com* and *surveymonkey.com*.

California elected two women to national AAUW offices: Kathleen Cha to Association Director at Large and Alicia Hetmnan, Education Foundation Director at Large.

Restructuring of AAUW: The restructuring and By-Law changes proposed by the Association Board were approved, as well as the public policy program with some changes submitted from the convention delegates. Effective July 1, 2009, AAUW and the Education Foundation will become one organization.

Keynote speaker, Sherry Schiller, worked with the Board using a strategic planning process to develop a clear vision. Changes were developed in the By-Laws for the health and survival of the Association. She said our vision of equity, justice, and respect must shape our actions. We need to model our values in all of our activities through cooperation, inclusiveness, building alliances with other organizations, and by not being tied to "old ways" of doing things.
