Getting Your 2014-15 Directory

The U.S. Post Office raised the cost of both Bulk Mail Permit and postage rates. The increase nearly doubled the cost. To save money, we will no long be mailing the Directories by bulk mail. (*To renew just the Bulk Mail Permit is now \$210. Mailing a single Directory is about \$2.20. If we had to mail 100 Directories, we would pay \$220. This is a big savings for the branch.*)

Tech Trek Grows a Generation

Seventeen years after the first Tech Trek Science and Math Camp at Stanford University, this year's campers experience was enriched by the participation of former Tech Trek campers who have gained enough education and experience in science and math fields to help run things.

Six girls from Los Gatos-Saratoga Branch were participants in this year's Grace Hopper Science and Math Camp at Stanford University the week of July 13-19. Assigned to a "core" unit of their choice (3D Math, Physics of Motion, Marine Biology, CSI Forensics), they swarmed over the campus to attend core classes and lectures and participate in star-gazing, field trips and Professional Women's Night.

Their week was greatly enriched by the involvement of prior Tech Trek campers in many parts of the program (teaching classes, conducting experiments, driving solar cars and answering questions at Professional Women's Night). These busy college students and graduate students commit their time to camp because they believe that their Tech Trek experience made a difference in their career choice and they want to ensure that other girls have the same opportunity.

While many campers build on their camp experience by serving as Junior and Senior Counselors at subsequent camps during their high school years, others return to the program from unexpected directions. Stanford and Cal Poly grads taught physics and robotics at this year's camp and current Stanford engineering students drove the solar car—two years in a row! One former camper (now a second year pharmacy grad student) was even a dorm mom for the past three years. The distinctive badge of a Tech Trek tee shirt lets girls know that they are part of a special team—even if it was years ago.



The commitment of graduate campers adds an extra dimension to the camp experience that sends a powerful message to everyone involved in this program. While we continue to collect metrics, we also continue to encourage the involvement of all former campers to enrich the current and future program with their real-world input.

Please plan to join us at our September 13 General Meeting to meet the girls in person. You will hear about their personal experience at camp and get the chance to ask questions and check out mementos they bring to share.
