

# A Great Time to Join AAUW



Our September meeting provided a great opportunity to hear about the various groups and committees and projects that our branch offers. That's just the beginning of a year full of opportunities to meet interesting and involved people, especially in smaller groups where you can really get to know other members.

#### Support Programs for Girls and Women in STEM

Our society tells girls and women that they don't belong in science, technology, engineering, and math (STEM) fields. **Tech Trek** was designed to show girls who have finished seventh grade that there are many options and opportunities for them and a wide range of careers which require a background in STEM. If you met the Tech Trek campers in September, you know that their week at Stanford excited them about these fields of study and will help them plan their academic futures to prepare them for college work and ultimate employment in these fields. Our Tech Trek Committee works with our middle schools to nominate candidates, interview the girls, and select our campers.

Local Scholarships are given to women from West Valley College who are transferring to a four-year college or university to pursue a degree in any of the STEM areas. Many recipients had not thought about majoring in STEM until they met a particularly influential teacher at the community college who encouraged them and inspired them. They appreciate the financial and moral support they get from AAUW. Our Local Scholarship Committee makes sure the application is available to interested applicants, reviews the applications, and selects the recipients.

#### **Help Women in Crisis**

It's hard to believe that here in prosperous Silicon Valley there are homeless women and children. Several agencies work with these women to help them find employment, housing and critical social services so that they can become self-supporting. Our Committee on Homeless Women and Children provides both financial support to these agencies and direct assistance to the women with an annual holiday party and gift giving, and by providing lunch once a month at the Women's Gathering Place.

#### Meet Members with Similar Interests

AAUW members like getting together socially. Some share their interest in reading or playing bridge, others go walking or hiking, still others simply go out to lunch. # Single-payer Health Care, What Do You Know?

The is a first in a series of articles on Myths &Lies about Single-Payer Health Care

Let's start with a definition of single-payer health care. Physicians for a National Health Program describe it as follows:

Single-payer national health insurance, also known as "Medicare for all," is a system in which a single public or quasi-public agency organizes health care financing, but the delivery of care remains largely in private hands. Under a single-payer system, all residents of the U.S. would be covered for all medically necessary services, including doctor, hospital, preventive, long-term care, mental health, reproductive health care, dental, vision, prescription drug and medical supply costs.

The program would be funded by the savings obtained from replacing today's inefficient, profit-oriented, multiple insurance payers with a single streamlined, nonprofit, public payer, and by modest new taxes based on ability to pay. Premiums would disappear; 95 percent of all households would save money. Patients would no longer face financial barriers to care such as co-pays and deductibles, and would regain free choice of doctor and hospital. Doctors would regain autonomy over patient care.

I am going to be sharing information provided by a group called Public Citizen, which is a non-profit, non-partisan, consumer rights advocacy group and think tank based in Washington, D.C. This group advocates before all three branches of the United States federal government. They have been working for 25 years, supported by donations, to provide information to citizens.

# What are the Myths and Lies about Single Payer?

• The Affordable Care Act ("Obamacare") provides universal coverage and protects patients from abusive insurance companies, so we don't need Single Payer.

Wrong! Under the Affordable Care Act, you are required to purchase coverage from a forprofit insurance corporation. Corporations like Aetna, Blue Cross/Blue Shield and others still control access to doctors,

hospitals and coverage; the insurance industry arguably has more power with the Affordable Care Act in place than before. Meanwhile 33 million Americans sill lack access to health care under Obamacare. This means thousands of people will continue to die in the United States each year because they lack access to health insurance.

• Single payer is government-run health care.

Wrong. That would be the Veterans Administration. Or the British health care system where the government pays for the doctors and hospitals. Under single payer, you get a health care card, and you can go to any doctor or hospital in the United States. Doctors are not employees of the government. Hospitals remain in private hands. You get free choice of doctor and hospital.

# Sign up for Great Decisions 2016

Great Decisions, a program by the Foreign Policy Association (FPA), is America's largest discussion program on world affairs. Anyone can participate. The program model involves reading the Great Decisions *Briefing Book*, watching the DVD and meeting in a Discussion Group to discuss the most critical global issues facing America today. Background information and policy options are provided for the eight most critical issues facing America each year and serves as the focal text for discussion groups across the country.

The 2017 will be dealing with the following topics:

- 1) European Union
- 2) Trade
- 3) China
- 4) Gulf Cooperation Council/Saudi Arabia
- 5) Geopolitics of Energy
- 6) Latin America
- 7) Afghanistan/Pakistan
- 8) Nuclear Security.

Locally the program is sponsored by the League of Women Voters of Southwest Santa Clara Valley, The American Association of University Women Los Gatos-Saratoga Branch, the Saratoga Area Senior Coordinating Council (SASCC) and the Saratoga Retirement Community (SRC). The 2017 program is expected to function with two groups, as it did in previous years.

The registration fee for Great Decisions 2017 is \$35 for an individual and \$45 for a couple sharing a workbook. Everyone desiring to participate is urged to sign up as soon as possible. The signup deadline is November 30, 2016, to insure that course materials are received in time for the start of the local program.

# What Do the Ballot Measures Say and Do?

A total of 17 measures have qualified for the November 2016 ballot. In addition, there may be county or city measures in your area to be voted on locally. Several propositions amend the state Constitution. Some amend current law (statutes); others create new laws. One is an advisory vote, asking voters' opinions. One is a referendum, seeking to overturn a current law.

Not all of the propositions address issues that relate to AAUW principles, priorities and mission. Five of the seventeen are relevant to AAUW, and we have taken positions on those five. The remainder are categorized as "no position." However, it is important to understand each measure in order to make an educated vote.

The information below gives a summary of each proposition. The AAUW position is noted for each of the five relevant measures, along with the rationale for the position. At the end, there are some references where you can find additional information on any of the propositions.

#### **AAUW SUPPORTS**

**51** (*Statute*): Authorizes \$9 billion in general obligation bonds for K-12 school construction and modernization, funds for community college buildings, funds for facilities for charter schools and technical education programs. **SUPPORT:** adequate and equitable funding for high quality public education for all students

**52** (Statute and Constitutional Amendment): Requires two-thirds vote of Legislature to amend a current law that imposes fees on hospitals; fees are used to obtain federal matching funds for Medi-Cal. It directs fees and matching funds to uncompensated care provided by hospitals and to children's health coverage. It eliminates the law's ending date. **SUPPORT:** guarantee equality, individual rights and social justice for a diverse society; increased access to quality, affordable health care.

55 (Constitutional Amendment): Extends the Prop. 30 (passed by voters in 2012) income tax on high earners through 2030 – currently set to expire in 2019. This will generate \$8 –11 billion per year to be used for public schools and community colleges, health care for low-income families, and local public safety. The public can track expenditures at www.trackprop30.ca.gov. This does not add taxes, buts, but continues taxes already in place. SUPPORT: Support for a strong system of public education; access to quality, affordable health care; guarantee of equality, individual rights and social justice for a diverse society. AAUW supported Prop 30 in 2012.

**58** (*Statute*): Amends 1998's Prop. 227 (*which requires children in public schools to be taught in English*) to allow public school students who speak limited English to be taught for a defined period of time in languages other than English. Districts using this option must develop an accountability plan and involve a parent advisory committee. Parents may opt out of the program. **SUP-PORT:** support for a strong system of public education that promotes gender fairness, equity and diversity.

#### **AAUW OPPOSES**

53 (Constitutional Amendment): Requires statewide voter approval before state may issue bonds of over \$2 billion to finance a single project. Prohibits dividing projects into segments to avoid public vote. Includes clause that if other bond measures on the ballot that conflict with this measure, and both that measure and this measure pass but this measure gets more votes, then the other measure is null and void ("poison pill clause").OPPOSE: the "poison pill" clause could nullify Proposition 51, which AAUW is supporting California PERSPECTIVE.

#### AAUW TAKES NO POSITION
