September News from Gifts for Teens! Did You Know? This is Why Your Help is Vital!

Gifts for Teens, as an AAUW Community Action Project, works year around to provide holiday gift bags to homeless and needy South Bay teens. But did you know the outreach this project has within our community and agencies serving this population? Our holiday gift bags serve as an incentive for teens to visit one of the 5 agencies we serve to access:

- counseling,
- health care, •
- housing help
- job training
- complete educational goals

In 2017, 1,285 gift bags were distributed to 655 teens living in inner city areas served by Sacred Heart Community Services and 4,441 homeless teens and youths in group homes served by Bill Wilson Center. Additionally served were the following teens – 102 Unity Care Group clients from 7 downtown group homes and 2 low-income apartment complexes; 25 homeless teens served by Home First; 49 Advent Group (2 homes for male teens and a training program for older youths); and 13 individuals from 3 poor families.



This outreach could not be done without the community's help. Gifts for Teens' 16 member all volunteer committee has been generously aided by AAUW San Jose members, local industry, the tech community, philanthropic groups and the community at large. In 2017, 383 volunteers worked during our gift bag assembly, 148 donors contributed \$86,267 and 110 donors gave personal items such as cosmetics, games, scarves ad store gift cards. Teens helping needy teens spearheaded donation drives at many high schools.

Joyce Ruth Ferris-Metcalf

May 5, 1037 – August 5, 2018 Resident of Los Gatos

Joyce Ferris-Metcalf, 81, of Los Gatos, California passed, early in the morning on Saturday August 5th in Brentwood California. Joyce was the eldest daughter (of 6 children), born to Ruth and Ladell Ferris of Cincinnati, Ohio.

Joyce worked exceptionally hard to pass the entrance exam to Walnut Hills High School, where the average IQ was above 110 and it was through the education there she applied and was accepted to Northwestern University, in which she started on September 15, 1954.

After Northwestern she attended Harvard Law School and finished at Louisville law school so that her first husband, Norman Nedde, could attend and finish medical school. After graduation, she was the only woman to join the Kentucky Attorney General's Office. They made their way out west to California where Joyce joined the Attorney General's office in San Francisco. After Norm moved his medical practice to the south bay, Joyce joined the Santa Clara County District Attorney's office. She spend more than 40 years in that office and most of it as the only woman on the homicide team *(where she only lost 1 case)*.

They also adopted 2 girls, Crystal & Susan, during this time. After an unfortunate divorce, Joyce married again, to Charles

Winthrop Metcalf. From that marriage came a beautiful incredibly intelligent little girl, Melissa, which was the light of her life.

Other local charities included the PEO Nearly New Shop in Sunnyvale and the St Andrew Church's Echo Shop in Saratoga. Ethel served as the director of the Cupertino Historical Museum and the director of the History Museum of Los Gatos.

Sarah Adams Model was born October 16, 1940 in Annapolis, Maryland, daughter of Captain Allen Bond Adams and Katherine Taylor Adams. She moved several times during her childhood due to her father's naval postings, with her happiest times at Miss Fines Preparatory School in Princeton, New Jersey. Following her education at Sweet Briar College in Virginia, Sarah settled in Manhattan, New York. While in New York, she worked for Governor Nelson Rockefeller and Secretary of State Henry Kissinger and at Goldman Sachs.

Looking for adventure, Sarah left the big city behind and moved to Honolulu in 1965. Eventually, the cost of living caught up to her and she moved to San Francisco, California, where she met her husband, Klaus, who had recently arrived from Germany. They were married in 1967 and celebrated their 50th wedding anniversary shortly before she fell ill.

After living in Palo Alto, Sunnyvale, and Cupertino, Sarah and her family finally settled in Los Gatos in 1985. While in Sunnyvale, Sarah completed her bachelor's degree at San Jose State University, giving birth to her first child, Fritz, right after her final exams. Her daughter, Heidi, was born five years later in Cupertino. Sarah worked part-time and helped raise her children, volunteering with the American Association of University Women. She was thrilled to have her children and grandchildren live close to her.

Sarah died peacefully at home on January 10, 2018 at the age of 77, following a brief illness. She was predeceased by her parents and her sister, Katherine Taylor Adams. She is survived by her husband of 50 years, Klaus Model, her son, Frederick (Fritz) Model of Almaden, and her daughter, Heidi Collins of Los Gatos. She has four grandchildren, Hanna (14), Amanda (13), Harrison (12), and Laurel (7).

There are 56 ethnic groups in China. "Han" people are the majority with 91.5% of the population in China. The rest, 8.5% of the population, consists of 55 minority ethnic groups. Reproductive Freedom is Tied to Women's Economic Security

This year marks the 45th anniversary of the landmark Supreme Court case *Roe v. Wade*, which legalized abortion in the United States. Access to safe and legal reproductive health care and information, including abortion, fosters self-sufficiency, promotes preventive health care, and protects individuals and their families from the spread of sexually transmitted infections. But control over one's reproductive life is also part and parcel to achieving economic autonomy; without reproductive choice, women cannot attain equal pay or opportunity in the workforce.

It's now a widely acknowledged fact that the typical woman working full-time brings home a paycheck that is 20% smaller than the typical man, and women of color tend to face larger gaps. But believe it or not, that number could be a lot worse. Lack of access to a full range of reproductive health services is one factor that contributes to those alarming statistics. Research suggests that the widespread availability and use of birth control pills in the 1980s and 1990s was partially responsible for narrowing the pay gap to where it is today.

Over a career (47 years), women's total earnings loss compared with men is \$700,000 for a high school graduate, \$1.2 million for a college graduate, and \$2

million for a professional school graduate. But women and girls who have access to reproductive health services are in a better position to tackle one element that leads to the gender pay gap. Research indicates that expanding access to reproductive services and information increases the prospect of economic security in adulthood for women. On the other hand, women who are denied abortions are more likely to receive public assistance, more likely to have an income below the federal poverty level, and less likely to be working full time.

As costs of both health care and child care skyrocket, it is paramount that women are able to control their own decisions about when, if, and how to start a family. The existing pay gap already hurts women, their families, and the economy. Limiting reproductive choices and access only compounds these issues. On the anniversary of *Roe v. Wade*, we celebrate our freedoms and look to a future in which increased access to critical health care leads to greater economic security and parity for women.


