Message from Our Co-Presidents

At our October board meeting we welcomed **Myra Sternlieb** as our new Public Policy chair. Myra is an RN, and has been serving as president of her national nursing sorority. She is passionate about the public policy issues that AAUW is concerned with and is forming a local group to work on these issues. We have not had a Public Policy chair in many years, so Myra will be a breath of fresh air! Read more about the AAUW California public policy priorities in this newsletter on page 5.

Coincidentally, our first program for 2024-2025 fell into the Public Policy area. On October 5, **Moira Barker** and **Kristen Murphy** spoke about changes and challenges in elementary education. It was such an informative and well-prepared presentation. They were gracious enough to share their slides with us. Click here to access them.

Kristin and Moira spoke about the challenges students and teachers have had after the COVID pandemic, especially the need for "Social and Emotional Learning." They discussed the new requirement for "Transitional Kindergarten," the challenges of declining enrollment, and how to create balance in children's lives so they can be successful students, but also be allowed to be children. An interesting idea was the concept of "Connectedness" so that each student has at least one adult at school with whom they feel comfortable discussing things they want to talk about. Kristin and Moira also discussed their framework for evaluating when students may need more support and how it is implemented. We invite you to review the slides. Their email addresses are in the slides, and they are willing to answer questions.

Finally, we were sad to note the passing of **Lilly Ledbetter**. She was a supervisor at Goodyear Tire and Rubber's plant in Gadsden, Alabama, from 1979 to 1998. When she was nearing retirement, she received an anonymous note revealing that she was making thousands less per year than the men in her position. Ultimately her lawsuit against Goodyear led to the passage of the Fair Pay Act of 2009 which was the first bill that President Barack Obama signed into law. AAUW California Public Policy Legislative Report Card

Out of 41 bills where AAUW California took a position, 29 made it to the governor's desk and 21 were signed; 12 bills died due to cost issues. Three of our A priority bills were signed:

- ➤ AB 2843: Health Care Coverage for Rape and Sexual Assault Survivors
- AB 2326: Public Postsecondary Education: Sex Discrimination Policies
- ➤ AB 2099: Protecting Reproductive Health

In addition, 2 of our B priority bills were signed:

- AB 1790: Requires CSU system to strengthen protections against sexual harassment
- ➤ AB 1831: Expands law prohibiting possession and distribution of material depicting minors performing sexual activities to include AI and computer-generated images

The governor also signed AB 1955 which prohibits public schools from notifying parents if their child uses a different name or pronouns or identifies as a different gender than assigned at birth. California is the first state in the nation to ban forced outing of transgender students.
