Great Decisions Discussion Group

We are pleased to report that the Cupertino Senior Center has agreed to host Great Decisions this Winter/Spring. Membership is open to seniors over 50; dues are \$30 for nonresidents and \$25 for residents. You can join at 408-777-3150 or online at www.reg4rec.org. The schedule and other details will be announced in a later newsletter. Participants are expected to purchase the briefing book before the first session. Here are the topics for Great Decisions 2026:



1. America and the World: Trump 2.0 Foreign Policy

Trump's return has marked a break from 80 years of U.S. foreign policy leadership, embracing an "America First" approach. This chapter explores the risks of isolation and diminished influence in relation to Trump 2.0 foreign policy.

2. Trump Tariffs and the Future of the World Economy

Trump's aggressive trade and tariff policies have shaken global economic norms. What's the rationale behind this radical shift in economic policy, and what are the implications for multilateral trade and geopolitics?

3. U.S. - China Relations

Relations with China remain tense, with tariffs, military modernization, and pressure on Taiwan. Does Trump have a coherent China policy, and will his tariffs on rare earth minerals be effective? What are America's strategic options?

4. Ruptured Alliances and the Risk of Nuclear Proliferation

U.S. alliance skepticism may drive countries like Japan and South Korea to reconsider nuclear options. What are the implications of the Trump administration's rethinking of the U.S. alliance system for regional and global security? Will this new uncertainty alter the way allies and rivals in various regions make decisions about security and nuclear weapons?

5. Ukraine and the Future of European Security

With reduced U.S. support for NATO and Ukraine, Europe faces strategic uncertainty. The Trump administration has signaled an intention to reduce its security role in Europe. What are America's stakes in NATO and Europe's strategic dilemmas? How might Europe respond?

6. Multilateral Institutions in a Changing World Order

Can multilateralism survive amid shifting global power and rising nationalism? This chapter examines the future of global cooperation across trade, health, and finance.

7. U.S. Engagement of Africa

Africa's geopolitical role is growing. What lessons can the U.S. learn from China's presence there, and how might it strengthen ties, especially with leading nations like Nigeria? What tools of statecraft might the U.S. bring to its engagement with Africa?

8. The Future of Human Rights and International Law

As democracy and human rights retreat globally—and the U.S. pulls back—how can civil society and legal norms remain effective in a divided world? What is the role and force of international law in this era of impunity?

Public Policy Committee News Proposition 50 – Special Election November 4

Normally AAUW publishes a list of formal recommendations to support or oppose propositions. National has advised that, as an organization, we are not able to make a formal recommendation about Proposition 50. The AAUW California Public Policy



Committee has published a Proposition 50 toolkit which is available on the AAUW-CA website at https://www.aauw-ca.org/aauw-california-public-policy-publishes-2025-prop-50-get-out-the-vote-gotv-member-toolkit/. This toolkit provides a wealth of information and talking points about this proposition. The last day to vote in the Special Election is November 4.

Update on Legislation Signed into law:

AB 260 protects medication abortion by establishing that the current standard of care for the use of mifepristone will remain legal in this state, protecting providers who legally provide mifepristone, requiring the continuation of existing coverage for medication abortion, and expanding access to reproductive health care through telehealth.

<u>SB 627</u> makes it a crime for law enforcement officers to wear facial coverings during their duties, except in certain situations.

Vetoed by the governor:

<u>SB 418</u> prevents sex discrimination in healthcare coverage in CA, specifically protecting anyone subject to discrimination, generally, and sex stereotyping, specifically, from losing coverage or being denied benefits in California based on sex.

<u>SB 771</u> addresses the problematic ways that major social media platforms have altered their content moderation practices, specifically allowing AI and algorithms to amplify credible threats and intimidation targeting historically marginalized groups.
